Procedure to register for SEMI FINALS EMX65 - 85

After the last race in the zone:

The first 25 riders in the championship have to REGISTER trough their Federation to the organising Federation of the SEMI FINAL, KNMV or FMI. (see Supplementary Regulations)

This registration must be done in the first 5 days after the last RACE in their respective zone. When there are not 25 riders of the respective zone registered, the SEMI FINAL will be filled up according to the championship standings and riders registered.

This means that also the riders who want to participate but who are not in the first 25, can already register immediately. They will be put on a reserve list.

Only riders who appear in the result list of the championship standings can participate.

The reserve list riders will be informed as soon as they can take part in the Semi Finals

The Insurance comes in effect 2 days before the first practise and ends 2 days after the meeting.

The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other incident.

13 - PROTEST AND APPEALS

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognized by the FIM and concerned by a decision taken under the authority of the FIM Europe, may ask for redress for the consequences of that decision.

Protest must be lodged according to the FIM Europe Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of € 350,00 or equivalent amount in local currency, returnable if the protest is justified.

In general, protests against eligibility of a rider entered, must be made before the start of the official practice.

Protests against results must be presented to the International Jury within 30 minutes following the publishing of the results.

An appeal can be made to the FIM Europe Disciplinary Commission against a decision of the International Jury.

In case of FIM combined races an appeal can be made to the FIM Stewards Panel against a decision of the Race Direction.

Protest entailing a fuel control: See FIM Europe MX rules.

14 - PRICE-GIVING CEREMONY

Additional other riders can be invited by Infront or the organizer. Riders might also be invited for a Press Conference.

If invited attendance to the prize giving ceremony or press conference is compulsory.
